Adoption Contract

Dobie Haven, Inc. (DH) hopes that you will be satisfied with and enjoy your new pet. At the same time, we are concerned about the welfare of the animal. In order to insure these objectives (DH) and the new owner jointly agree to following:

- Dobie Haven, Inc., (DH) agrees to the following:
 - To transfer legal ownership of the animal to the adopter.
 - To provide for dogs the following initial inoculations; Distemper, Hepatitis, Leptor, Parainfluenza, Parvovirus, and Rabies.
 - To have all adult dogs altered before transfer of ownership.
- You must agree to the following:
 - Not to keep animal on leased or rented property where a "NO PETS" policy is enforced.
 - To provide adequate fresh food and water, clean and dry shelter, and daily exercise.
 - To not keep animal on a chain, rope, or tether at any time.
 - To obey all applicable laws governing control and custody of animals, including laws governing the immunization of dogs against Rabies.
 - To take the animal to a licensed veterinarian for routine exams and immunization.
 - To provide medical care and treatment needed by the animal. This includes but is not limited to, one yearly medical exam, any vaccinations indicated by your veterinarian, and preventative heartworm medication.
 - To adopt the animal as a pet/companion, i.e., not as a gift, not as a working animal or guard dog, not to be used for animal research.
 - To give permission to DH to visit my premises at any time to insure this agreement has been kept.
 - To return the animal to DH rather than to place, sell, or abandon the animal.
 - That should dog be sold or given away to anyone other than DH, I will be held legally responsible for all financial loss suffered by DH including but not limited to vet fees, boarding costs, surgeries, and vaccinations since the dog's original acceptance into the DH program.
 - To hold DH harmless for any veterinary fees incurred by or damages caused by the animal while it is in my care.
 - To update DH with my current phone number and address at all times.
 - Ownership of dog can be revoked and dog reclaimed by DH should this contract be broken in any manner.
 - To keep current ID tags on animal at all times.
 - Agree that DH can revoke ownership if DH feels the animal is being neglected.
 - I understand that DH has limited knowledge about the dogs, that any known problems have been disclosed, that I as the adopter am responsible for any future liability, that I as the adopter agree to indemnify DH from any future liability.
 - I agree to pay the adoption fee of \$ _____. Please note, we spay/neuter, treat any medical problems, feed, house and give all our love to these loving dogs in our own spare time, we do not make a dime, all the money goes to pay vet bills.

I HEREBY VERIFY THAT I AM TWENTY-ONE (21) YEARS OR OLDER, THAT I FULLY UNDERSTAND MY OBLIGATIONS AS DESCRIBED ABOVE AND THAT FAILURE TO COMPLY WITH THESE OBLIGATIONS WILL BE A BREACH OF CONTRACT, WHICH GIVE DH THE LEGAL RIGHT TO TERMINATE ANY OWNERSHIP OF THE ANIMAL THEREBY THE LEGAL RIGHT TO RECLAIM THE ANIMAL WITH REFUND.
